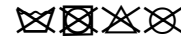
### Fitting Instructions:

Place kneepad so the knee joint is in the centre of the pad with the shell away from the knee. Wrap top strap above the kneecap and bottom strap below the kneecap. Fasten closure on the outer side of the knee.

**Sizing:** One size.

### Cleaning:

Clean by hand. Scrub with soft brush. Air dry. Do not machine wash, do not place in dryer, do not use bleach, do not dry clean.



### Storage And Transport:

When not in use, store this garment away from extremes of temperature. If it is wet, allow it to dry slowly and naturally away from direct heat sources before placing it into storage.

### Wear Life:

The exact useful life of this garment will greatly depend on how and where it is used as well as following storage and care instructions. It is therefore important that you examine it before use and replace it as soon as it appears to be unfit for wear. If it becomes damaged, it will NOT provide the optimum level of protection, and therefore should be replaced as soon as is practicable. Never knowingly wear damaged product while carrying out a risk related activity. This garment does not have an expiry date.

### Use:

These garments are designed for protection against mechanical injury to protect all the knee area against superficial injuries, such as abrasion, perforation, or cuts. Pad is covered with flame resistant FR fabric to protect when there's exposure to flames. The use of this PPE does not reduce the hazard itself nor does it guarantee permanent or total protection. **DO NOT USE FOR SPORTS OR ATHLETIC ACTIVITIES.**

**RECOMMENDATIONS:** Kneel in an upright position; do not sit on your heels. Do not kneel with knee protectors for long periods of times without stretching. After kneeling for an hour, walk about for at least ten minutes without any knee protectors attached to your leg.

This garment is not water resistant.

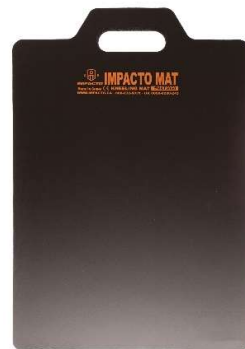
