Place seat protector on your buttocks. Wrap elastic straps around legs and fasten hook and loop closure. Wrap webbing strap around your waist and fasten buckle closure.

M (21" from waist to bottom of leg, 17" waist width, 48" waist strap),
L (23" from waist to bottom of leg, 19" waist width, 48" waist strap),

WEIGHT (LB): 3. Sold per Each. Case: 10.

Washing Instructions:

Hand wash with lukewarm water and mild detergent. Scrub with soft brush. Air dry. Do not use bleach, machine wash, place in dryer or dry clean. Note: frequent washing of leather products will make the leather less supple.
