Fitting Instructions:

Loosen elastic straps. Position belt just below the navel. Attach front closure to desired level of comfort. Before you lift, or when additional support is desired, grasp ends of elastic straps, pull around to the front and fasten. Secure elastic straps for a comfortable fit. When lifting is completed, loosen straps and re-attach with less tension to some point further back on your side. Suspenders may be attached at the waist with the hook and loop fasteners provided.
