Fitting Instructions:

Place the UPGUARD on your shoulders over the upper/top of back and clip the two fasteners to either your belt or pant tops. The adjustable straps should be positioned to provide a loose fit that does not pull on the shoulders. Moving the clips further out from the center of the stomach area will provide better stability.

Sizing: One size.

Washing Instructions:

Hand wash in cold water and mild detergent. Air dry. Do not machine wash or place in dryer. Allow webbing to completely dry before re-using.

Limitations of Use:

These products are physiological aids. It is important to wear it comfortably fastened at all times. Do not wear the UPGUARD if you suffer from severe Rheumatoid Arthritis, Ankylosing Spondylitis, Reiter's Syndrome, Psoriatic Arthritis, Downs Syndrome, Enteropathic Arthritis or any condition predisposing upper neck instability. If there is any question consult physician prior to use.
