## **Fitting Instructions:**

- 1) Identify the area of the tool where the VEP waffle sheet is to be applied. Mark and cut the sheet to desired size.
- 2) Clean tool handle to remove dirt or grease.
- 3) Remove paper backing on the VEP sheet. With the waffle side out, wrap sheet around the tool handle. Where the sheet begins to overlap mark with a pen and cut with scissors. The original end and the newly trimmed end should meet with no overlap.
- 4) Spirally wrap the tape over the VEP with the blue line showing. The thin tape should overlap half the width of the tape per wrap around the handle. Use the blue line as your guide. While wrapping the tool handle peel the cellophane backing from the tape and stretch the tape to ensure proper sealing.
- 5) Once the VEP has been covered, cut the tape from the spool.
- 6) For correct fit, use a knife or scissors to cut VEP away from trigger, vents or other areas of the tool to prevent interference with normal and safe use of tool.


